## An Unusual Foreign Body in Stomach: Dining Fork

An 18-year-old male patient applied to the emergency department with complaint of fork swallowing. Abdominal film of the patient showed meal fork in the stomach. Laboratory signs of the patient were normal. The fork in the stomach of the patient was removed surgically.

Some foreign bodies (FBs) result in immediately apparent complications, whereas others remain asymptomatic and undetected. Malpractice lawsuits against emergency physicians regarding failure to diagnose or treat retained FBs result in the fifth highest amount of indemnity awards paid to patients.<sup>[1]</sup>


### CASE REPORT

An 18-year-old male patient applied to the emergency department with complaint of fork swallowing. During anamnesis, it was learnt that he had eaten yoghurt together with fish for lunch, then he had been worried about poisoning and while trying to vomit with fork, he had swallowed the fork. Epigastric tender-

ness was observed during physical examination. Abdominal film of the patient showed meal fork in the stomach (Fig. 1). Laboratory signs of the patient were normal. The fork in the stomach of the patient was removed surgically and the patient was discharged two days later.

### DISCUSSION

Literature scanning shows that FBs, such as coin, battery, needle, bottle, glass, etc. are frequently encountered inside the gastrointestinal system.<sup>[2-5]</sup> However, no fork aspiration was encountered so far. Possibly, this is the first case in the literature. Treatment depends on the swallowed object. While sharp objects

and batteries are surgically removed, blunt objects like coins are expected to be discarded

with defecation.<sup>[6]</sup> This article aims to remind the need that general public must be informed that myths such as eating fish together with yoghurt causes poisoning are not real as well as to present atypical foreign body in the stomach.
